Momentum's default rates include:

- The Energy Component;
- Pass-Through Charges; and
- Environmental Charges.

Energy Component – comprises the Unbundled energy rates set out below, plus:

- the daily charges applied to the Supply Address immediately prior to termination of the Contract (unless varied by Momentum); and
- the metering charges applied to the Supply Address immediately prior to termination of the Contract (unless varied by Momentum).

Pass-Through Charges are charged on a pass-through basis.

Environmental Charges – the Environmental Rates set out below shall be used to calculate the Environmental Charges.

Unbundled Pricing Supply Addresses

Consumption at Unbundled Pricing Supply Addresses is charged at peak rates from Monday to Friday during the following hours: 7am - 11pm in VIC (AEST), 7am - 10pm in NSW and ACT (AEST), 7am - 9pm in SA (ACST), 7am - 11pm in QLD (AEST). Consumption outside these hours will be charged at off-peak rates.

The Unbundled rates displayed above do not include the Environmental Rates. These are set out below.
