<b>OFFER TERMS:</b>	<p>Capitalised terms that are not defined in these Special Terms are defined in the Market Retail Terms for Small Customers.</p> <ol style="list-style-type: none"> <li>1. To be eligible for this offer, your Supply Address must be located in Victoria.</li> <li>2. Subject to clause 3:             <ol style="list-style-type: none"> <li>i. we'll waive any special meter read, connection and disconnection fees payable by you under our Market Terms and Conditions when you move into the Supply Address, and</li> <li>ii. if you've moved into the Supply Address from premises that we're Responsible for, we'll waive, or reimburse to you via a credit on your first electricity bill, any special meter read and/or disconnection fee payable (or paid) by you for that move.</li> </ol> </li> <li>3. We won't waive (or reimburse to you):             <ol style="list-style-type: none"> <li>i. after hours or same day fees imposed by your distributor, or</li> <li>ii. connection fees where you're moving into a new estate, or into a residence that hasn't had electricity connected for 12 months or more.</li> </ol> </li> <li>4. To be eligible for the \$50 (GST incl) online sign up credit (<b>Welcome Credit</b>):             <ol style="list-style-type: none"> <li>i. you must sign up at momentum.com.au</li> <li>ii. the Contract must be your first electricity market retail contract with us for the Supply Address (<b>New Contract</b>), and</li> <li>iii. the New Contract must not end before a bill is issued for the first billing period under the New Contract (<b>First Bill</b>).</li> </ol> </li> <li>5. We'll pay you the Welcome Credit:             <ol style="list-style-type: none"> <li>i. for each New Contract you sign up at momentum.com.au, and</li> <li>ii. as an offset against the Charges on the First Bill (subject to clauses 6 and 7).</li> </ol> </li> <li>6. You won't get the Welcome Credit if the New Contract ends before the First Bill is issued.</li> <li>7. If the First Bill contains Charges of less than \$50 (GST incl), we'll carry over the Welcome Credit balance to your next bill, excluding a final bill. If the New Contract ends before you've incurred Charges to the value of \$50 (GST incl), you'll forfeit your Welcome Credit balance.</li> <li>8.
