## ENERGY PLAN

Plan name SmilePower Flexi - Geelong Cats

### **Eligibility criteria**

To be eligible for this plan:

- 1. you must be a member of the Geelong Football Club
- 2. the Supply Address must be in Victoria, South Australia, New South Wales or the Energex distribution zone of Queensland
- 3. pay your bills in full by direct debit for the life of the plan, and
- 4. unless the Supply Address is registered for life support, you're experiencing payment difficulty, or the Regulatory Instruments require otherwise:
  - a) receive your bills, notices and other communications Electronically\*, and
  - b) principally communicate with us Electronically\*.
- $^{\ast}$  Electronically means by email, MyAccount, SMS, or any other electronic means.

### Additional terms

You must tell us immediately if your circumstances change in a way that you've become, or may become, ineligible for this plan. If you notify us of a change, or we become aware of a change, we may, acting reasonably and with prior written notice to you:

1. seek your agreement to vary the Market Contract (for example, by varying the Charges)

- 2. end the Market Contract and seek to negotiate a new one with you, or
- 3. end the Market Contract and continue to sell you energy at the Standing Offer Prices relevant to the Supply Address.

# EXTRA PRODUCT

### **Renewable promise**

These Extra Product Terms must be read with the Market Contract. In these Extra Product Terms:

- Hydro Tasmania means our parent company, the Hydro-Electric Corporation (ABN 48 072 377 158);
- RECs means renewable energy certificates, including small-scale technology certificates and large-scale generation certificates; and
- Renewable Energy means energy generated from renewable resources (e.g. sunlight, wind or water).
- 1. We'll:
  - a) ensure that Hydro Tasmania or another electricity generator will generate an equivalent amount of Renewable Energy as we bill you for in that same calendar year; and
  - b) engage an external auditor to examine the reconciliation of the Renewable Energy generated against the quantity of the renewable promise.
- 2. You acknowledge that:
  - a) the electricity supplied to the Supply Address comes from the grid and consists of energy generated from both renewable and nonrenewable sources, so you won't necessarily receive Renewable Energy;
  - b) the renewable promise isn't accredited by the National GreenPower Accreditation Program and the Renewable Energy referred to in clause 1(a) won't give you any rights to claim or receive RECs or any other environmental product, whether or not the Renewable Energy is eligible to produce those certificates or products;
  - c) we've made no representation to you that our renewable promise will reduce the quantity of greenhouse gas emissions attributable to you at law, or achieve any other purpose, and you've relied on your own investigations, interpretations, deductions, information and determination in deciding whether the renewable promise is

suitable for you;

- 3. We may stop offering the renewable promise as an Extra Product by at least 20 Business Days prior written notice to you. If we stop offering the renewable promise, the Market Contract will continue unless it's also ended in line with the General Terms.
- 4. If you cease to be eligible for our renewable promise, these Extra Product Terms will no longer apply.

### \$75 Visa Gift Card

- 1. You'll receive one \$75 Visa gift card for each Supply Address not already on a Momentum Energy plan that you sign up on to this plan (**Eligible Address**).
- 2. A link to redeem the Visa gift card will be sent by email to the email address nominated during the sign-up process.
- 3. If you cancel your account for your Eligible Address at any time before a bill for the first billing period on that account is issued, the Visa gift card is forfeited.
- 4. The Visa gift card will be sent to your email address up to 45 days after a bill for the first billing period on that account is issued.
