## **ENERGY PLAN**

### **Plan name**

Suit Yourself Electricity

### **Eligibility criteria**

To be eligible for this plan:

- a) the Supply Address must be located in Victoria, South Australia, New South Wales or the Energex distribution zone of Queensland; and
- b) you must:
  - i) be a residential customer (which means a customer who purchases energy principally for personal, household or domestic use), and
  - ii) receive your bills, notices and other communications Electronically, unless the Regulations require otherwise.

### **Additional terms**

1. A payment processing fee will apply to all card payments. You can find a list of our fees and charges at [momentumenergy.com.au/fees-charges](https://momentumenergy.com.au/fees-charges). For direct debit card payments, the fee will be included in the total amount debited. For other card payments, the fee will be added to your next bill.
2. If we reasonably determine that you are not eligible for this plan (for example, you don't meet our credit eligibility criteria) or you subsequently become ineligible for this plan, we may end the Market Contract by prior written notice to you. If this happens and we're Responsible for the Supply Address, we'll

continue to sell you electricity at the Standing Offer Prices relevant to the Supply Address.

3. We may vary or retire the plan, by prior written notice to you. If we vary the plan, our notice may include a link to details of the variation on our website.

## **EXTRA PRODUCT TERMS**

### **GreenPower**

1. In these Extra Product Terms:

- **Clean Energy Regulator** means the independent, Australian statutory authority responsible for administering legislation to reduce carbon emissions and increase the use of clean energy;
- **GreenPower Generator** means an electricity generator approved under the National GreenPower Accreditation Program that reduces greenhouse gas emissions within the electricity sector and produces net environmental benefits;
- **GreenPower Product** means a product certified under the National GreenPower Accreditation Program. It refers only to the GreenPower Percent of any Momentum product offering and may consist of one or more GreenPower Product options;
- **GreenPower Charges** means the amount payable for a GreenPower Product;
- **GreenPower Percent** means the proportion of your total usage quantity that the GreenPower Product applies to, as elected by you;
- **GreenPower Rate** means the dollar amount (cents per kilowatt hour) applicable to the GreenPower Product;
- **National GreenPower Accreditation Program** means the voluntary, government-accredited program that enables electricity retailers to purchase Renewable Energy on behalf of your household or business; and
- **Renewable Energy** means energy generated from natural resources (like sunlight, wind and water).

2. These Extra Product Terms:

- a) apply, if you have chosen our GreenPower Product; and
- b) cease to apply if we are unable to continue to provide our GreenPower Product to you for any reason.

3. You must pay the GreenPower Charges in addition to other Charges payable under this Market Contract.
4. The GreenPower Charges in a billing period are calculated by multiplying the GreenPower Percent by the total usage quantity at all relevant Supply Addresses during that billing period, and then multiplying this by the GreenPower Rate.
5. We will ensure that an equivalent amount of Renewable Energy is generated from GreenPower Generators as is purchased by you. We will fulfil this commitment through voluntarily surrendering the corresponding amount of eligible large-scale generation certificates to the Clean Energy Regulator.
6. As the energy supplied to your Supply Address under this Market Contract is sourced from the national electricity grid, you acknowledge that the energy supplied to your Supply Address will not necessarily be Renewable Energy.
7. If you no longer wish to purchase our GreenPower Product, or you would like to change your GreenPower Percent, you acknowledge that the Market Contract under which you purchased our GreenPower Product will be terminated.
8. If, after the date that you and we enter into this Market Contract, we incur any liability, cost or reduction in benefit due to or arising from a change to the National GreenPower Accreditation Program, and we reasonably determine that there is any increase in the direct or indirect cost to us of purchasing or selling energy to your Supply Address, then we may vary your Charges in accordance with your Market Contract.
